Music Professor Emeritus/Composer Stays in the Spotlight

Aurelio de la Vega is Honored by Library of Congress and Campus Birthday Concert

Cal State Northridge music professor emeritus Aurelio de la Vega, an acclaimed composer who taught here for 34 years, (*right*) has a lot to celebrate upon reaching his 75th birthday. De la Vega is featured in two publications recently issued by the Library of Congress, and had his birthday feted on campus with a special concert.

De la Vega's music manuscript, "The Magic Labyrinth," has been included in a 733-page volume, "Music History from Primary Sources," published by the Library of Congress in July. Two of his pencil-colored graphic scores also illustrate the month of May in the library's 2001 wall calendar titled "Classical Music."

And, last Sunday, November 19, music professor Daniel Kessner and The Discovery Players, a student ensemble, performed a campus concert honoring de la Vega's birthday. With de la Vega attending, the concert included the West Coast premiere of his work "Bifloria" for solo guitar.

Music Department chair Jerry Luedders said the recent recognition of de la Vega is the latest of many awards for the Cuban-born composer. "He is internationally recognized. His compositions are performed by orchestras and distinguished artists around the world," Luedders said.

The new Library of Congress book, in addition to de la Vega's piece, includes works by Bartók, Beethoven, Brahms, Chopin, Gershwin, Handel, Liszt, Mahler, Mendelssohn, Mozart, Puccini and Stravinsky, among other great names in music history.

"When I saw the book in August, I cried," de la Vega said. "It is an honor to be included with such beautiful music." As for the calendar, de la Vega said he did not even know he was included until a friend saw one at a bookstore. "Then I went to [a bookstore] and saw a display and thought, 'Wow'."

De la Vega was born in Havana, Cuba, in 1925. He served as a cultural attaché at the Cuban Consulate in Los Angeles. He also toured the United States as a lecturer from 1952 to 1959 before settling in Los Angeles.

De la Vega then became a music professor at San Fernando Valley State College, which was renamed Cal State Northridge in 1972. De la Vega ultimately taught at the university for 34 years before retiring in 1993.

In addition to his teaching duties, de la Vega was an active composer and lecturer. His list of compositions includes symphonic pieces, chamber music, piano, ballet music, guitar and electronic music. Major orchestras and prominent soloists throughout the world have performed his works.

De la Vega has been the recipient of many prizes and distinctions, including having twice received the Friedheim Award of the Kennedy Center for the Performing Arts. At CSUN, Luedders said de la Vega was recognized for his teaching work and for his artistry in composing.

Now, de la Vega said he is enjoying retirement. "I have been traveling more than ever and composing more than ever. In a way I am even more completely free to plunge into the music than I was before," he said.

Nonetheless, de la Vega said he misses his former colleagues and students at the university at times. "I loved to teach," he said. "One of the most beautiful things you can do is pass on to someone what you know. That communication of giving something to the next generation makes me very warm inside. When you put love into it, the students respond and that's what it's all about."

CSUN Retains Ranking as Third Largest Campus in CSU

Total Cal State Enrollment Climbs During Fall 2000 for Sixth Straight Year

Cal State Northridge remained the third largest campus in the California State University system during fall 2000 based on student enrollment, according to a new recap from the CSU Chancellor's Office that also shows the system recorded its sixth consecutive year of enrollment growth.

CSUN's official fall 2000 enrollment figure hit 29,066, an increase of 1,119 students and about 4 percent above the comparable fall 1999 tally of 27,947. This fall's enrollment was the largest fall number for the university since 1992, when the student headcount was 29.092.

Around the CSU system, San Diego State had the largest fall enrollment with 31,609 students, followed by CSU Long Beach at 30,920 and Northridge at 29,066. CSU Fullerton ranked fourth in size with 28,381 students. The fall 1999 enrollment rankings had the same top three list of San Diego, Long Beach and Northridge.

Systemwide, the CSU's total enrollment increased by 8,533 students to 368,252, slightly less than the historic peak of 369,053 in 1990. During the past six years, the CSU has grown by nearly 49,000 students, an increase of 15.3 percent.

This fall, 18 of the 22 CSU campuses including CSUN posted enrollment increases.

CSU to Review and Strengthen Student Alcohol Policies

Chancellor Appoints Committee of Presidents and Students to Make Recommendations by the Spring

California State University Chancellor Charles B. Reed has appointed a committee of CSU presidents and students to review the university system's alcohol policies and prevention programs, with a goal of strengthening them so fewer students are injured or die as a result of alcohol abuse.

Chairing the committee will be CSU Fresno President John Welty, who also is the vice chair of BACCHUS, the international association of college- and university-based peer education programs focusing on alcohol abuse prevention.

"This is an extremely important issue," Welty said. "Recent studies indicate that there are new approaches that could help combat this serious problem among university students. We want to take a look at what we now have in place and what we could be doing better."

Shaun Lumachi, chair of the California State Student Association, is identifying five or six students to work with the university presidents' committee. "The CSU is doing the right thing by addressing this serious issue. We are supportive of Chancellor Reed's call to come up with solutions for our college campuses," Lumachi said.

The CSU presidents on the new committee are Tomas Arciniega, CSU Bakersfield; Manuel Esteban, CSU Chico; James Lyons, CSU Dominguez Hills; Stephen Weber, San Diego State, and Bob Caret, San Jose State.

Recent incidents at two CSU campuses prompted Chancellor Reed to move in this direction. A fraternity pledge at CSU Chico died after ingesting a considerable amount of alcohol. Two different fraternity-related incidents at San Diego State involved underage drinking and hospitalization of pledges. The three fraternities at the two universities have been suspended while the cases are being investigated.

While the incidents involved Greek organizations, Reed and the presidents recognize that the problem goes beyond fraternities and clubs, and involves the general student population.

"We can not look at alcohol abuse as just a way of college life," Reed said. "We need to increase awareness of the problem and then find some solutions that really work and not just come up with policies that sit on a shelf. Our children's lives are at risk, and universities need to make every effort to prevent any more lives from being wasted."

Welty said he expects his committee will make a report to the chancellor and the Board of Trustees in early spring.
