Urban Studies

1. Program Modification. Proposed reorganization of core requirements and streamlining of specializations for URBS. Does not change units in major but shifts around courses in categories and clears up what is a 'core' requirement and what is a 'specialization'. Revises and adds specializations.

Anthropology

2. New Course Proposal. New 3-unit course proposed entitled "Anthropology of Sex". Proposed as as an elective for Anthropology majors/ minors as well as a course for GE Social Science Section. Early implementation requested if possible within EPC guidelines. Approved for early implementation; department asked to revised the course description.

Sociology

Course Modifications

- SOC 498 AEE/BEE/CEE. For course presently entitled "Field Study and Reports." Proposed changes include a title change and clarified/updated catalog description. Corequisite is 498S. Approved for early implementation.
- SOC 498S. For course presently entitled "Seminar in Field Study and Reports." Proposed changes include a title change and a clarified/updated catalog description. Corequisite is 498AEE/BEE/CEE.

Program Modification.

5. Proposed reformulation of "Option IV" within Sociology's BA program. Proposed changes: change in title of Option IV to reflect broader aim, clarification of requirements and change to several Option IV courses (400/400L, 482, 483.) Early implementation requested if permissible within EPC guidelines.

The following are the course modifications associated with the SOC Program Modification.

- 6. SOC 400. For course entitled "Organizational Analysis and Lab." Proposed title change; modified course description; unit re-adjustment (from 2/1 lecture and lab to 3 unit lecture.)
- 7. SOC 400/L. For course entitled "Organizational Analysis and Lab" Proposed dropping of lab component of SOC 400. Catalog presently states that 400 and 400L are co-requisites.
- 8. SOC 482. For course entitled "Practicum in Counseling and Guidance". Proposal to change course title and course requisites..
- 9. SOC 483. For course entitled "Proseminar in Counseling and Guidance: Work Settings". Proposal to change course title and course requisites.
- **D.** Discussion of Hybrid Courses was tabled until March 25, 2009.
- **E.** Cynthia Rawitch reviewed Executive Order <u>1037</u>. The executive order, she explained, requires our campus to revise our Repeat Policy and Withdrawal policy.

It was **MSP** that EPC would review new policy statements for Repeats and Withdrawals on March 25, 2009. The new policies should be reviewed and approved by the Faculty Senate before the Executive Order's effective date of August 1, 2009.
