Changing S-factor to C-factor "in a course taught as C-factor	CM	Need outline and representative syllabi from current and/or most recent

previously”		semester, justification (include enrollment data)
Changing S-factor course taught as S-factor, to C-factor	CM	Need all information usually requested in NC proposal. (include enrollment data)
Larger C-factor to smaller C-factor	CM	Justification statement that would cite relevant curriculum information (ex: change in evaluation methods)
“Family” of proposals – several courses with same request from 1 dept or across departments	Memo and representative CM listing all courses in family	Refer to the type of change listed above to identify data needs
Previously taught C-factor to Mixed mode course (i.e. mixing two C-factors)	CM separating the two factors, or modified “combo” form	Need course outline, justification (include enrollment data if previously taught course)
