The committee discussed EO 1100 (formerly EO 1065), which states that a grade of "C" or better is required in the four basic skills subjects courses for all students in order to receive GE credit. EPC will develop a policy to implement the directive without requiring course modifications for the affected departments and programs (if possible) for Fall 2016 implementation. A grade of "C" or better in basic skills subjects is already required of transfer students. The grade requirement will be effective for previously disqualified CSUN students in Fall 2015 and currently matriculated CSUN students in Fall 2016.
