#### I. Announcements

- A. There was no update for Graduation Initiative 2025.
- B. E. Adams provided an update on General Education (GE) assessment. Under the direction of the Office of Academic Assessment and Program review, departments with courses in GE (beginning with Basic Subjects and then rotating through each section) will conduct GE assessment in place of program assessment using the current GE SLOs. The assessment can be incorporated into GE program review as a whole or the program review of the department.

#### II. Business

- A. The minutes from 9/21/16 were **MSP approved** (one abstention).
- B. D. Wakefield reported on the Psychology department exit meeting. External reviewers had laudatory comments about the department's work on assessment, closing the loop and making curricular changes to facilitate student learning. They highlighted the need for more resources to serve students better. The department has a large number of students (3,000 undergraduates) and relatively small number of faculty (29 tenure-track). Recent impaction of the undergraduate major will probably be focused on more during the next review.

#### C. College of Humanities **Religious Studies New Experimental Topics Course**

 RS 396RSJ – Religion and Social Justice in Los Angeles (3). MSP approved with changes and pending the completion of the two week consultation period.
