- E. L. Becker shared feedback provided by the Faculty Senate regarding EPC's proposed revisions to the Standardized Breaks in Classes Policy. The committee discussed Senate's concern that the policy says breaks are recommended and not required. Since breaks are not a requirement under the current policy and concern was raised about unintended consequences of making breaks a requirement, the committee decided to maintain the policy recommendation as originally proposed.
- F. L. Becker updated the committee regarding consultations that occurred for the Scheduling of Instruction Policy recommendation. He consulted with CFA, Council of Chairs, GSC, and Faculty Affairs. Most consented to the proposed changes. Faculty Affairs raised a concern that the current policy says faculty cannot be scheduled for more than five hours unless the dean signs off; the proposed policy says more than six hours without faculty consent. After a brief discussion about the hours and the dean's involvement, the committee decided to revisit the policy recommendation at the next meeting.
