- A. C. Mayberry announced that the Withdrawal Unauthorized Policy Recommendation was not voted on at the last Faculty Senate meeting. It will be agendized for the next Faculty Senate meeting on December 7.
- B. C. Mayberry announced that the Faculty Senate voted not to reconsider the motion to not participate in the implementation of Executive Orders 1100 Revised and 1110. This means EPC will continue to approve curriculum under the current guidelines.

E. Adams said tabled GE proposals will be considered at the upcoming EPC meetings. She also clarified that the president's announcement about keeping Section F was under a very specific set of circumstances which became null when the faculty voted not to implement either executive order.

- E. Although there was no further discussion of EO 1100, committee members asked about EO 1110. C. Mayberry reminded the committee that the Faculty Senate motion included both executive orders and implementation of EO 1110 was not reconsidered. E. Adams noted that existing stretch writing and MATH 196QR already comply with EO 1110.

L. Campbell asked about course placement without the ELM and EPT exams. E. Adams said the Chancellor's Office will provide guidelines using multiple measures, such as SAT or ACT score and overall GPA. The campus is looking into the ability to access individual grades for high school math and writing courses.

K. Luna expressed concern from the Writing Council about Early Start and the effect on stretch writing. E. Adams said Early Start is not changing for 2018. The campus will need to determine the Early Start course if EO 1110 is implemented for 2019. However, there is no reason for the course to change the structure of the writing program.
