- Library operations update: Print books from the Library's collection are available by mail. Course Reserves are a challenge, as there are limited copies of print items, and loan periods are usually only 2-4 hours. Faculty are encouraged to select course materials in eBook format. The Library will only be purchasing eBooks for fall 2020 and spring 2021.
- Questions raised by committee members:
 - O. What is the loan period for main collection Library items? A. Faculty may borrow the item(s) for one year.
 - Q. Are journals being renewed? A. Usage statistics are under review, which will determine titles to continue subscriptions on. We should be able to renew most of our journal subscriptions.
 - Q. Can faculty make book recommendations? A. Yes, please send requests to your department's
 <u>Library subject specialist</u>. There may be a delay due to staffing and Course Reserve request taking
 priority at this time in the semester. Building a strong case for the book in need is recommended.
 - Q. What about the Elsevier situation? A. CSUN signed a 2-year contract in April 2020. Faculty members now have the option to publish Open Access in Elsevier journals at no charge.
