- N. D. Stephens and P. Lazarony shared a proposal from the Strategic Scheduling Team to consider moving the start time of 3-unit daytime lecture courses by 30 minutes, with the first class offerings starting at 8:30 a.m. (instead of 8:00 a.m.) beginning in Fall 2024. The proposed change does not affect night classes. The proposal has been presented to various faculty and student groups for feedback. In addition, questions will be incorporated into the upcoming student survey. The proposal was motivated by several factors including classroom utilization and the later 8:30 a.m. start time at California high schools. Colleges have been asked to look at the challenges of scheduling linked lecture/lab courses. D. Stephens noted that the current schedule has a gap from 3:15 p.m.-4 p.m., which can absorb the shift from an 8 a.m. start to an 8:30 a.m. start. P. Lazarony said they have reached out to Metro to ensure that the proposed change would not impact access to bus schedules. D. Stephens and P. Lazarony invited feedback. Several members and guests asked questions about the potential impact, including lab/activity course scheduling and concerns about public transportation schedules.
- O. AB 928 discussion was postponed due to lack of time.
